MAP of Lot-338 CLEARWATER BEACH SEC-2

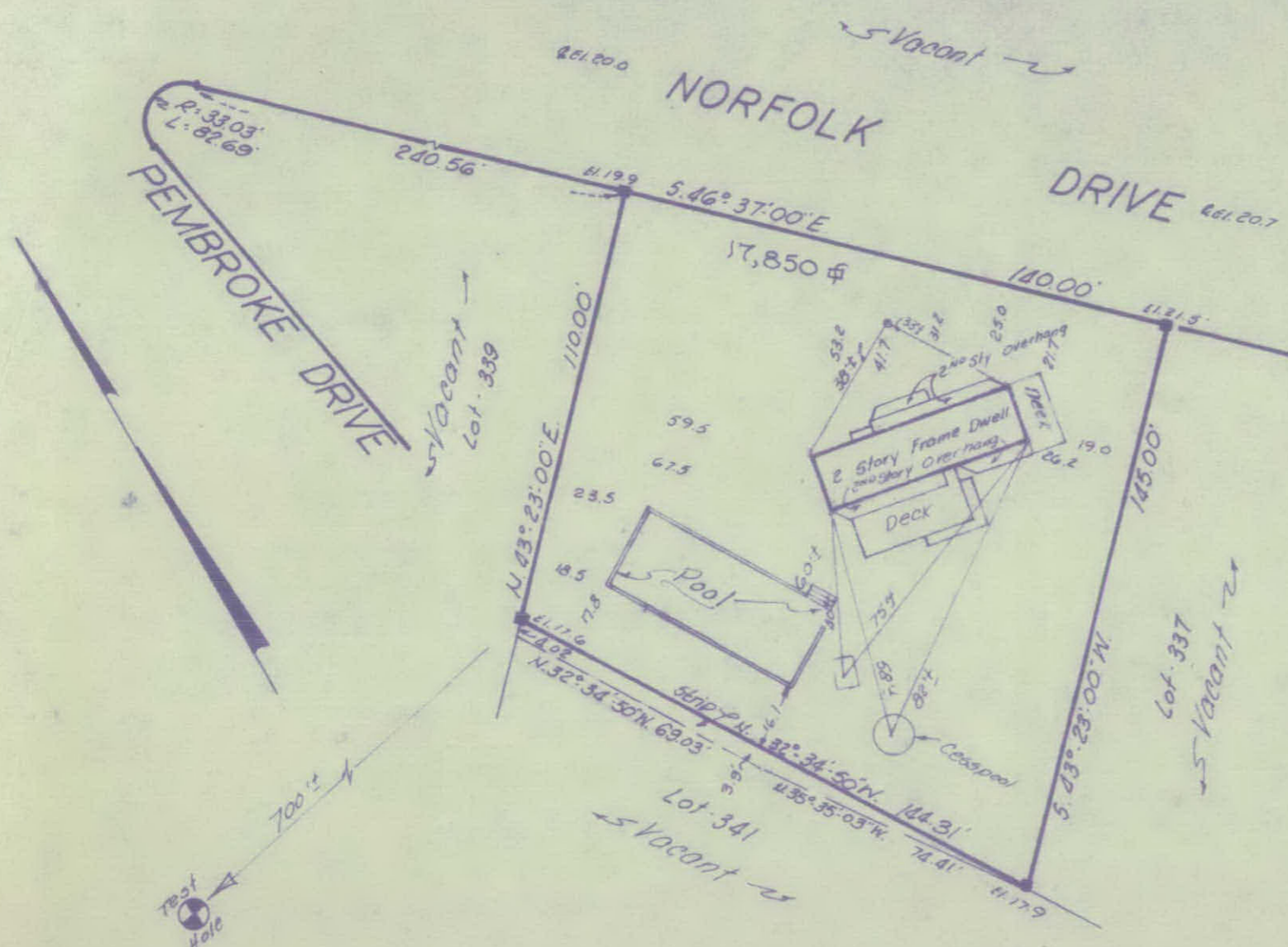

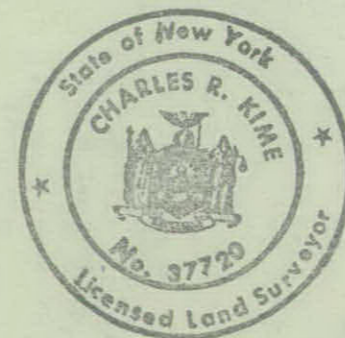

MAP of CLEARWATER BEACH-Section 2

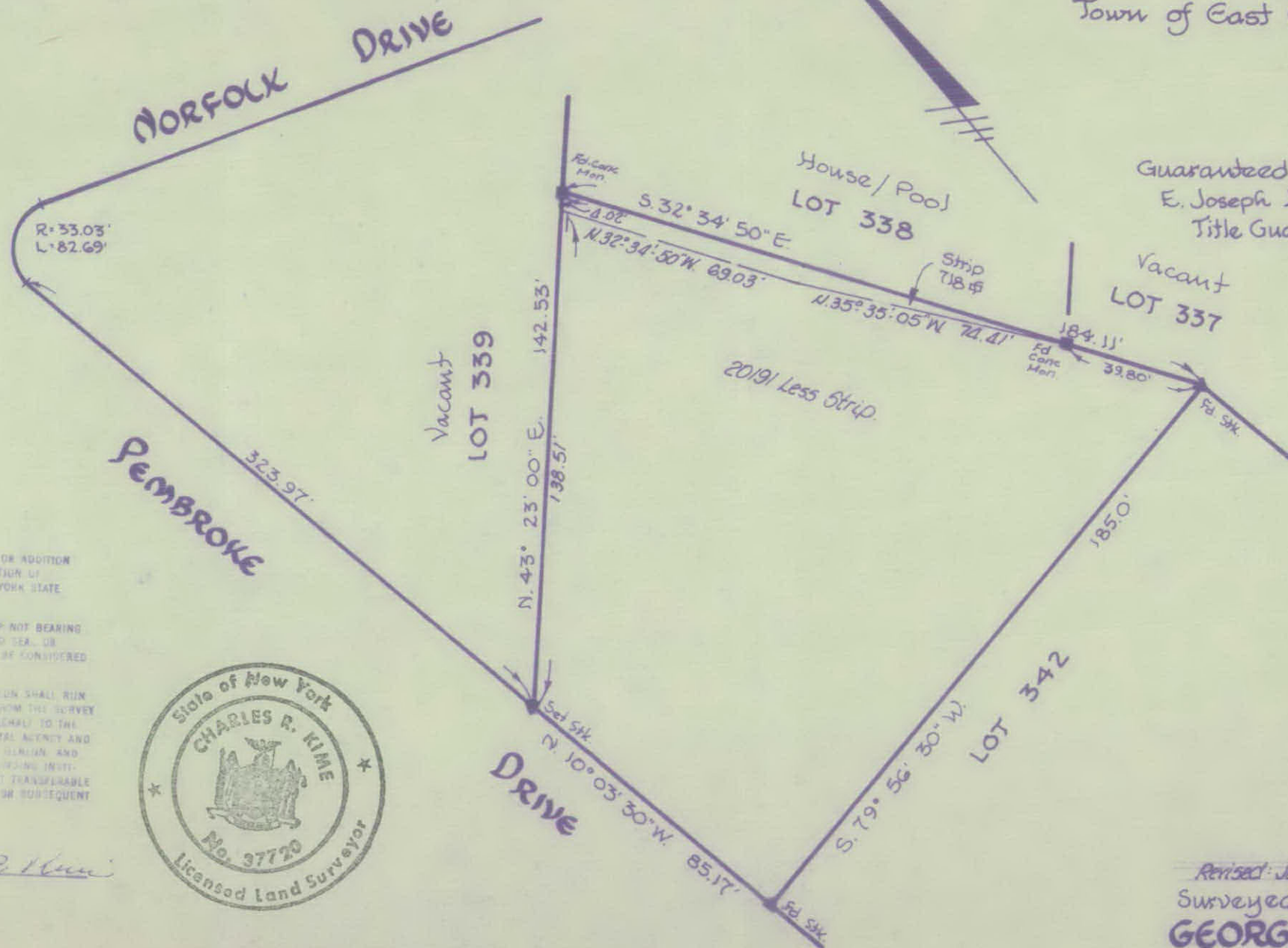
